Session 1- Inauguration and Keynote Speech



Ms. Stuti Narain Kacker: IAS Retd., Chancellor, Subharti University, Former Secretary, DoEPwD and Chairperson, National Commission for Protection of Child Rights (NCPCR)

She initiate the idea of Think College and said that it is a new chapter in the Inclusive Education.

She later focused on these points:

- Rights of person with disability.
- Right to education especially for Person with Intellectual Disability.

- She said Inclusive Education is not enough for employment we need certification as well.
- She asked to share more stories and spread these success stories because still children are not fitted in education system.

At the end she said to follow the path by which PIDD can earn and support their family. And she proceeds with the short film.



Ms. Huma Masood: National Programme Officer, Gender and Education, UNESCO

She share her own experiences related to the higher education scenario of PIDD. She started way back 1994 movement towards inclusive education and then after some time we got PwD Act.

She introduces some overlapping challenges. She asked to follow constructive model and do work beyond these discussion and conferences.

She said madam Shakuntala Gamlin Madam is also very dedicated towards this work. After that she focused on various issues related to transport facilities, aids and appliances. She said Inclusive Education should be based on Equity, Justice and Fairness. She quote "Ek diya dusre diye ko jalata hai." She told about the society scenario that her experience towards PIDD. She quote how layman shows their sympathy to PIDD.



<u>Dr. Alok Bhuwan:</u> Managing Secretary, Manovikas.

Dr. Alok presented the objective think college and as well as for conference. He introduces the educational transition towards school to college.

She asked about Inclusive Education that after school what to do and invited people to think over this and come together for the success of this idea.

Session 2 – Needs and facts of Inclusive Education for children with Intellectual and Developmental Disability



<u>Dr. J. P. Singh</u>, Former Member Secretary, Rehabilitation Council of India

He shares his experience about rehabilitation. He describe about education system prospective and perception about special education and vocational training programme.

He stated the success story of Aarambh and said Aarambh is prarambh. He suggested for parents counseling and especially for mothers.

He said that we are working on a mobile application Bharam Jyoti. On this application anyone from anywhere can upload videos and captions. In which student with special need are performing the activities. Activities will suggest parents how to trained PIDD at home. He ask to make videos of 2-5 minutes of activities. The organization can use their name also.



Dr. Amit Chaturvedi,

Regional Director, Regional Centre Delhi-2, Indira Gandhi National Open University (IGNOU)

He shares his experiences of IGNOU with PIDD.

He explain the story of Geeta (A deaf and dumb girl), who Sushma Swaraj rescued from Pakistan and brought back to India. Still she does not meet her family. Amit sir got permission from District Magistrate to meet Geeta. She started crying when she saw Amit sir.

He suggested parents counseling is important and we need to share success stories to motivate them. He quote 2011 Census data of PwD.

He introduces some barriers.

- Lack of environment in rural areas.
- Lack of resources.
- Lack of trained teachers.
- Need of Improvement in training program
- Lack of motivation to put them in mainstream.

Session 3 – Education opportunities through National Institute of Open Schooling (NIOS)



<u>Dr. Rajiv Kumar Singh</u>, Director (Academics) NIOS

He said NIOS has very flexible policies. We have on demand examination system if candidate is not ready for exam he\she can appear in on demand exam.

He said learning distance programme, transit learning material 24*7 on Gyanamrit channel for PIDD.

7 subjects are already available in Indian Sign language. Senior Secondary subjects for sign language is in progress.

NIOS study material available in all languages. He gives credit to Dr.Sukanta K. Mahapatra for converting 3 subjects into sign language in 100 days

He said we are always open to take suggestions and action will be taken accordingly.
